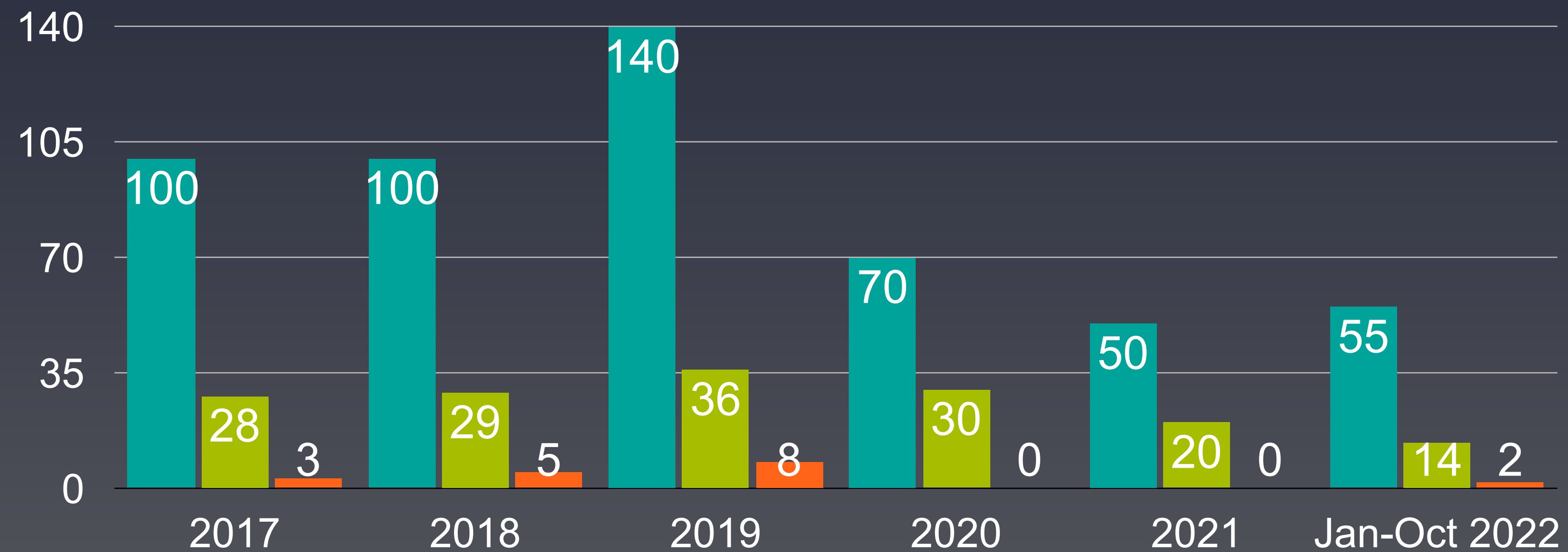

- 2022-01: Personal Data in the RIPE Database

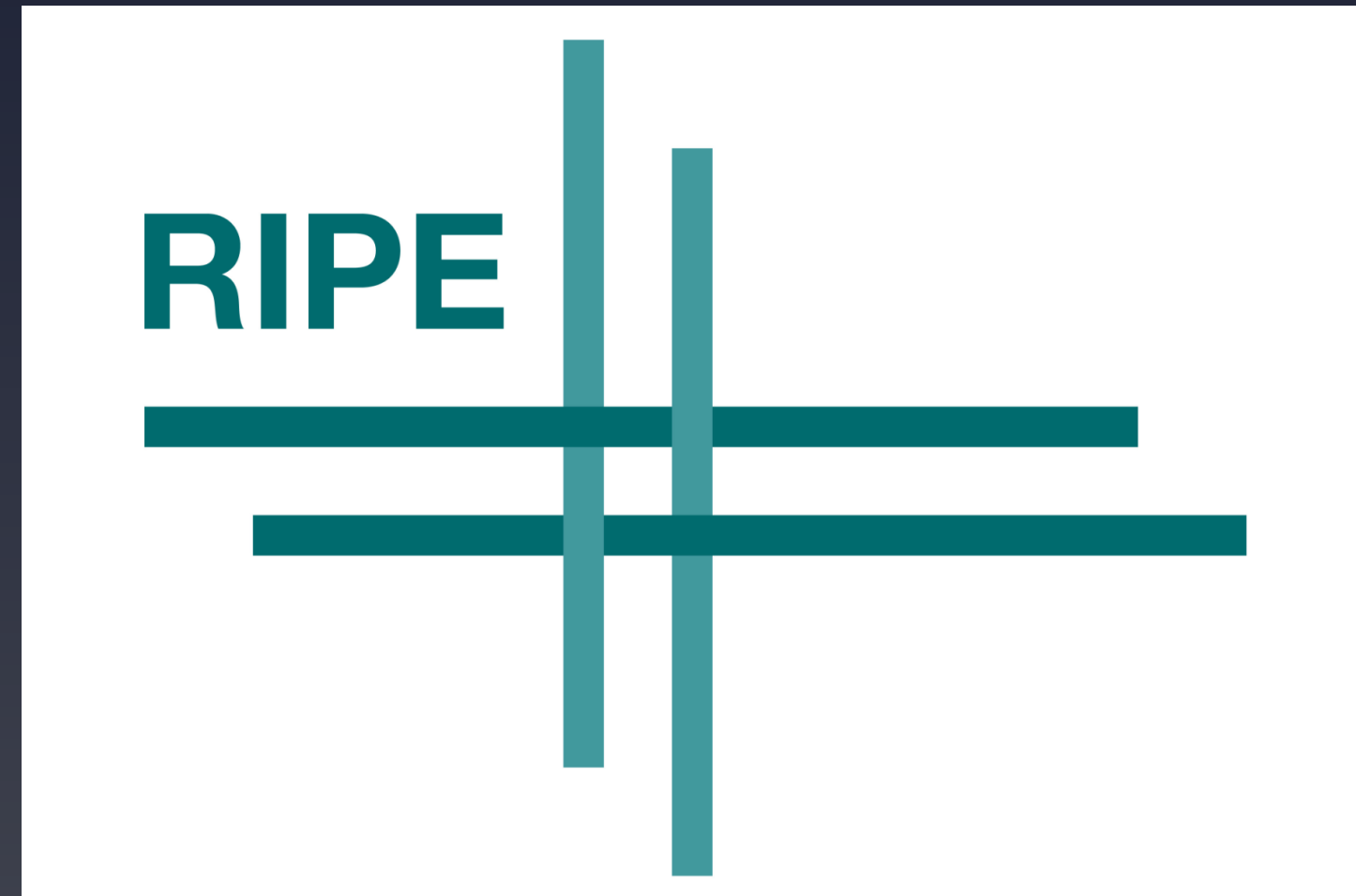
